<b>What is their role?</b>	To act as a voice for Strathdearn by gathering and expressing community views to Highland Council and other bodies and to take action in the interest of the community	To administer community benefit funds on behalf of the community. Can hold assets and employ or contract staff	To achieve sustainable regeneration through overseeing delivery of Strathdearn Community Development Plan. Can hold assets and employ or contract staff and contractors

<b>What do they own?</b>	CCs cannot own assets	Raigbeg Green	Strathdearn Hall plus contents and grounds (including Sports Area and playground)
<b>How are decisions made?</b>	Makes representations on planning and other matters. Makes recommendations to SCCT and SCD	Receives recommendations from SCC – decisions made by Trustees have to be compliant with Deed and charitable purposes	Board decisions have to be compliant with Company law and charitable purposes. Some important decisions are voted on by company members as Special Resolutions

<b>How are people appointed as Councillors Directors &amp; Trustees?</b>	Election- every 4 years People with right skills can be co-opted	Appointed by other Trustees	Annual elections from members One appointment each by SCC and SCCT People with right skills can be co-opted
